ORDER:

Whereas, the Andhra Pradesh (Issuance of Integrated Registration and Furnishing of Combined Returns under various Labour Laws by certain Establishments) Act, 2015 (Act No. 10 of 2015) has been enacted by the Legislature of the State of Andhra Pradesh facilitating ease of doing business and ease of compliance of Labour Laws specified in the First Schedule of the said Act, by the industry and the said Act 10 of 2015 came into force with effect from 23rd April, 2015;

2. And whereas, the Department for Industrial Promotion (DIPP), Government of India made certain recommendations and out of the said recommendations, one of the recommendation is to facilitate online furnishing of combined return under Labour Laws;

3. And whereas, in pursuance of the said recommendations, the Commissioner of Labour, Andhra Pradesh has proposed to amend Form - B suitably to mandating online submission of combined Return under the Labour Laws specified in the Schedule;

4. And whereas, the State Government, after taking into consideration of the said recommendations, have felt expedient to amend the Form- B given in the Second Schedule to the said Act, suitably.

5. Accordingly, the following Notification will be published in the Extraordinary issue of the Andhra Pradesh Gazette.

6. The Commissioner, Printing, Stationary and Stores Purchase, Andhra Pradesh, Vijayawada is requested to furnish 100 copies of the Notification to the Government and 25 copies to the Commissioner of Labour, Andhra Pradesh, Vijayawada.
